- Discuss adapting your emergency management response in a dynamic emergency environment.
- Identify the role of training, exercises, and community/state partnerships, in continuous improvement.

**Emergency Management Risk Assessment (EP0919)**

**Sept. 19**

This session will reimagine emergency preparedness in a post-pandemic world. We will identify risks, hazards, and threats to healthcare operations and safety using a robust Hazard Vulnerability Analysis.

**Emergency Management Planning (EP0921)**

**Sept. 21**

This session will offer ways to strengthen your planning process for the six critical elements of an Emergency Operations Plan, including communications, staffing, patient clinical and support activities, safety and security, resources and assets, and utilities.

**Emergency Management Response (EP1017)**

**Oct. 17**

This session will discuss leading practices and their challenges in the execution of effective emergency management. This will include ways to modify and manage operations in a dynamic emergency environment.

---

**Emergency Management Evaluation (EP1019)**

**Oct. 19**

This session will discuss the role of training exercises and evaluation in continuous improvement and ways the application of exercises and events can strengthen emergency preparedness.
